ORDINANCE NO. 22-13

**AN ORDINANCE AMENDING CHAPTER 5, STREETS AND
SIDEWALKS, SECTION 5.27(d), DRIVEWAYS, OF THE
HICKORY HILLS MUNICIPAL CODE**

BE IT ORDAINED by the City Council of the City of Hickory Hills, Cook County, Illinois, as follows:

Section 1

That Chapter 5, Streets and Sidewalks, of the Hickory Hills Municipal Code, be amended by changing Section 5.27(d), Driveways, to read as follows:

5.27 DRIVEWAYS AND PARKING AREAS

...

(d) Driveway Dimensions. The maximum width of a driveway on private property shall be equal to the distance between the outer edges of the garage doors being serviced by the driveway plus two feet on each side. Where there is no garage being accessed, the maximum width of the driveway on private property is 24 feet in width. The maximum width of a driveway on public property where it accesses a street and crosses the sidewalk is 24 feet. All driveways must be setback at least three foot from an adjoining property; provided that the Building Commissioner can allow an administrative deviation, after consultation with the Alderman of the Ward, to permit a driveway with a setback of not less than one foot from the an adjoining property.

Section 2

The penalty clause contained in Section 1.06 of the Hickory Hills Municipal Code is adopted herein by reference.

Section 3

If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed insofar as they conflict herewith.

Section 5

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
