AN ORDINANCE APPROVING A REAL ESTATE PURCHASE AND SALE AGREEMENT FOR THE PROPERTY LOCATED AT 9755 SOUTH 78TH AVENUE BETWEEN THE CITY OF HICKORY HILLS AND CHICAGO TITLE LAND TRUST COMPANY, AS TRUSTEE UNDER TRUST AGREEMENT DATED NOVEMBER 11, 2008 AND KNOWN AS TRUST NUMBER 08-3067

Section 1
