ORDINANCE NO. 23-04

AN ORDINANCE AMENDING CHAPTER 31, LICENSES, OF THE HICKORY HILLS MUNICIPAL CODE BY CHANGING SECTION 31.12(b), TOBACCO AND ELECTRONIC CIGARETTE DEALER & SPECIALTY DEALER, TO DECREASE THE NUMBER OF LICENSES TO A TOTAL OF THREE

BE IT ORDAINED by the City Council of Hickory Hills, Cook County, Illinois, as follows:

Section 1

That Chapter 31, Licenses, of the Hickory Hills Municipal Code, be amended by changing Section 31.12(b) to read as follows:

31.12 TOBACCO AND ELECTRONIC CIGARETTE DEALER & SPECIALTY DEALER

...

(b) **License required and maximum number of licenses.** No person shall engage in the business of tobacco and electronic cigarette dealer or tobacco and electronic cigarette specialty dealer in the city without first having obtained a license therefor. The maximum number of licenses that the City shall issue for tobacco and electronic cigarette specialty dealers is three (3).

...

Section 2

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.


Section 4
