**ORDINANCE NO. 23-06**

**AN ORDINANCE AMENDING SECTION 34.07, LICENSE FEES AND LIMITATIONS, OF CHAPTER 34, ALCOHOLIC BEVERAGES, OF THE HICKORY HILLS MUNICIPAL CODE, BY INCREASING THE NUMBER OF CLASS I LIQUOR LICENSES BY ONE**

BE IT ORDAINED by the City Council of Hickory Hills, Cook County, Illinois, as follows:

**Section 1**

That Chapter 34, Alcoholic Beverages, of the Hickory Hills Municipal Code be amended by changing Section 34.07, License Fees and Limitations, to read as follows:

**34.07 LICENSE FEES AND LIMITATIONS**

All licenses shall be on a fiscal year basis. License fees shall be paid in full prior to the commencement of the license year, except that that local liquor control commissioner may allow fees to be paid in two equal installments, 50% prior to the commencement of the license year and 50% prior to the commencement of the second half of the license year. The license fee for each class of license and the maximum number of licenses in each class is as follows:

<b>Class</b>	<b>Description</b>	<b>Number</b>	<b>Fee</b>
A	Package sales only	7	\$1,210
B	Package sales only (beer, wine)	5	1,010
C	Consumption on premises only	9	1,275
CL	Consumption on premises, late hours	0	2,000
D	Consumption on premises, banquets	1	1,675
DL	Consumption on premises, banquets, late hours	3	2,000
E	Consumption on premises, beer and wine	6	1,175
F	Consumption on premises and package sales	2	1,675
G	Veterans consumption on premises	0	75
I	Restaurant-Service Bar, consumption on premises	2	1,225
M	Municipal consumption on premises, beer and wine	0	0
W	Entertainment	no limit	550
X	Caterer	0	800

The number of licenses authorized herein for all classes shall remain at the number set forth in this section; provided, however, that any license in said classes which is revoked, or not used because of the termination of liquor business on the premises for which the license has been issued, shall automatically reduce the number of authorized licenses of the particular class by the total number of revoked or not used licenses in the particular class.

**Section 2**

The penalty clause contained in Section 1.06 of the Hickory Hills Municipal Code is adopted herein by reference.

**Section 3**

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

**Section 4**

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.


**Section 5**
