TWO SETS OF STAMPED PLANS AND ONE PLAT OF SURVEY REQUIRED.
 After foundation is in place, contractor must submit a survey locating foundation and grades. Contractor must NOT proceed with construction until the plotted survey is approved by the Building Commissioner. Sewer permit from the MWRD is required for any commercial building. The MWRD final inspection report is necessary before Certificate of Occupancy will be issued. All work must be started within 6 months and must be completed within one year of issuance of permit. Dumpster and portable toilet required. Site must be clean at all times. The issuance of a building permit is not to be construed as authorization or permission to use a building or property for any specific use. Use of buildings and properties must be in compliance with provisions of the City of Hickory Hills Zoning Ordinance. Indication of a use on a plan for building permit does not authorize said use upon granting of a building permit. Exterior walls must be face brick extending at least 8 feet or to the underside of soffit. It is the responsibility of applicant to comply with all requirement codes and regulations of the Roberts Park Fire District even if not indicated on blueprints. Sod and trees required. Trees should be 2" or more in diameter every 74'. If streets are not kept clean at all times, the cost of cleaning will be deducted from the street bond at builder's expense.
