Thank you for your interest in the Hickory Hills Street Fair.

The Street Fair is located on Roberts Road from 9100 to 9500 South. The registration booth is located near 94th Street, at the south end of Roberts Road.

Check-in time is 6:00 A.M. until 9:00 A.M.

Please be aware of the following guidelines for **FOOD**:

- ❖ Registration will be taken, and spaces assigned on a first come, first served basis.
- ❖ Prior registration is mandatory. There will be a \$10.00 LATE ENTRY FEE.
- ❖ Food vendor entry fees:
 - \$125.00 for a 15 ft. X 10 ft. space for pre-packaged/prepared food items (i.e. soup mixes, sauces, dip mixes, etc.)
 - Food Trucks or other food vendors, please contact Alessandro Vazquez: Alessandro@brewavenueevents.com
 - \$20.00 discount on each additional space for pre-packaged foods.
- ❖ **MUST COMPLETE "COOK COUNTY DEPARTMENT OF PUBLIC HEALTH" FORM AND PROVIDE A COPY OF YOUR BUSINESS LICENSE, LAST 2 INSPECTION REPORTS, EGG LICENSE (IF SELLING EGGS), SHARED KITCHEN LICENSE OR CONTRACT (IF COOKING IN A SHARED KITCHEN) AND COTTAGE FOOD CERTIFICATE OR APPLICATION THAT IS REVIEWED.** All food vendors will be subject to inspection by a certified food inspector.
- ❖ **ALL TENTS MUST BE WEIGHED DOWN**
- ❖ **IF USING PROPANE, YOU MUST HAVE A DRY-CHEM EXTINGUISHER**
- ❖ We reserve the right to deny an applicant.
- ❖ Vendors must be set up prior to 9:30 A.M., as no vehicles will be allowed on the street after that time.
- ❖ Parking on parkways is allowed, weather permitting.
- ❖ Set-ups must remain in place until 7:00 P.M. NO EXCEPTIONS.
- ❖ **If you need electricity, you must make your own arrangements. * Portable Generators are not allowed.**
- ❖ **NO PETS ALLOWED**
- ❖ NO RAIN DATE. NO REFUNDS.
